

The Broadcasting Council of the Republic of Macedonia, based on Article 37, paragraph 1, indent 5 of the Law on Broadcasting ("Official Gazette of the Republic of Macedonia", No.100/05, 19/07, 103/08, 152/08, 6/10, 145/10, 97/11, 13/12 and 72/13), and Article 120-a, paragraph 2 of the Law on Electronic Communications ("Official Gazette of the Republic of Macedonia" No. 13/2005, 14/2007, 55/2007, 98/2008, 83/10, 13/12, 59/12, 123/12, 23/13), and in accordance with Article 19, paragraph 2, indent 10 and Article 20, paragraph 1, indent 1 and 3 of the Rules of Procedure of the Council (consolidated version), No.01-4301/1 dated 14 August 2012 and the Conclusion No.02-2259/2 dated 17 May 2013, at its 24<sup>th</sup> meeting, held on 17 May 2013 adopted a:

PLAN AMENDING THE PLAN  
FOR ASSIGNMENT AND ALLOCATION OF THE TRANSMISSION CAPACITIES OF DIGITAL  
TERRESTRIAL MULTIPLEX No.01-6569/1 dated 26 December 2012  
("Official Gazette of the Republic of Macedonia" No. 168/12)

Article 1

Article 11 of the Plan for assignment and allocation of the transmission capacities of digital terrestrial multiplex ("Official Gazette of the Republic of Macedonia" No. 168/12) is amended and reads as follows:

"The schedule of television program services of trade broadcasting companies in the electronic programme guide (EPG) for MUX6 and MUX7 shall be determined by the Broadcasting Council, annually, according to data coverage and share in the ratings. Services at the state level shall be first, then the service at a regional level, according to official data contained in the market analysis of the broadcasting activity in the previous year. In 2013 the schedule of services at the regional level shall be in alphabetical order. "

Article 2

Article 12 of the Plan for assignment and allocation of the transmission capacities of digital terrestrial multiplex ("Official Gazette of the Republic of Macedonia" No. 168/12) is amended and reads as follows:

"In the Republic of Macedonia, in accordance with the final acts of the RRC-06 the following has been established:

- Eight (8) allotment zones: D1 – Crn Vrv, D2 - Stracin, D3 - Turtel, D4 - Boskija, D5 - Pelister, D6 - Mali Vlaj, D7 - Stogovo and D8 – Popova Sapka and

- The allotment zone D1-Crn Vrv consists of two (2) subzones of broadcasting: Skopje and Veles area or regional level area of Skopje and regional level area of Veles. The regional level area of Skopje includes the City of Skopje and the municipalities: Cucer Sandevo, Aracinovo, Ilinden, Petrovec, Zelenikovo, Studenicani and Sopiste. The regional level area of Veles includes the municipalities: Veles, Caska, Sveti Nikole, Lozovo, Gradsko, Rosoman, Negotino and a part of Kavadarci.

In Annex 2 the distribution zones are provided.

In Annex 3 the distribution of multiplexes in the zones of distribution is provided. "

### Article 3

Article 13 of the Plan for assignment and allocation of the transmission capacities of digital terrestrial multiplex ("Official Gazette of the Republic of Macedonia" No. 168/12) is amended and reads as follows:

"Programme services of trade broadcasting companies that broadcast programme with state coverage, shall be broadcasted in all zones of distribution.

Programme services of trade broadcasting companies that broadcast programme with regional coverage, shall be broadcasted in the allotment zone for which they have obtained a broadcasting license. "

### Article 4

Annex 2 of the Plan for use and distribution of the transmission capacities of digital terrestrial multiplex ("Official Gazette of the Republic of Macedonia" No. 168/12) is amended and reads as follows:
