

Pursuant to Article 69, Paragraph 5 of the Law on Audio and Audiovisual Media Services (“Official Gazette of the Republic of Macedonia” Nos 184/13, 13/14, 44/14, 101/14, 132/14, 142/16, 132/17, 168/18 and 27/19, and “Official Gazette of the Republic of North Macedonia” Nos 42/20 and 77/21, at its Session held on 4 August 2021, the Agency Council adopted the following

### **Plan amending**

## **The plan for assignment and distribution of the digital terrestrial multiplex capacities of an operator of public electronic communication network that is obligated to transmit the broadcasters’ programming services**

### **Article 1**

Following Paragraph 1 of Article 2 in the Plan for Assignment and Distribution of the Digital Terrestrial Multiplex Capacities of an Operator of Public Electronic Communication Network that is Obligated to Transmit the Broadcasters’ Programming Services (“Official Gazette of the Republic of Macedonia” No. 55/15), a new, Paragraph 2, shall be added, as follows:

“For the frequency sub-band of 694-790 MHz, the Godolo 2017 Multilateral Framework Agreement shall apply, concluded among the member states of SEDDIF (SOUTH EASTERN DIGITAL DIVIDEND IMPLEMENTATION FORUM), pursuant to the Decision (EU) 2017/899 of the European Parliament and of the Council of 17 May 2017.”

### **Article 2**

“Annex 3 shall be replaced by a new Annex 3, which shall be an integral part of this Plan.”

### **Article 3**

The wording “Republic of Macedonia” in Article 5, Paragraph 1, of the Plan for Assignment and Distribution of the Digital Terrestrial Multiplex Capacities shall be replaced by the words “Republic of North Macedonia”.

### **Article 4**

This Plan Amending the Plan for Assignment and Distribution of the Digital Terrestrial Multiplex Capacities shall enter into force on the eighth day following that of its publication in the “Official Gazette of the Republic of North Macedonia”, and shall be published after obtaining the consent of the Government of the Republic of North Macedonia.
